Rules and Regulations of Columbia Foundation Society.

1. The membership of the society shall be open to all the residents of Delhi/India.
2. The admission fee for all members shall be Rs. 200/- and the monthly subscription shall be Rs. 100/- per month.
3. The Managing Committee shall have full power to expel any member from the society on the following events:
 - a) if he has not paid his monthly subscription for more than three months constantly;
 - b) if he has not attended three meetings of the society without any intimation;
 - c) on his written resignation or his death;
 - d) the reason for expulsion from membership shall be communicated to the member.
4. All the appeals should be sent to the Managing Committee of the society. Decision of the managing committee will be final. The reason for rejection shall be communicated to the person concerned.
5. Any member who has been expelled by the managing committee, he/she can be re-admitted provided he/she pays all upto date dues alongwith Rs. 500/- as re-admission fee.
6. The source of income of the society shall be grants, donations, special contributions, admission fee and subscriptions.
7. All income of the society shall be deposited in the Bank.
8. The Bank Account of the society shall be operated by any two office bearers from President, Secretary and Cashier.

9. The General Body shall consist of all members of above category as described in membership clause.
10. The general body will consider any business brought forward by the managing committee, including the budget and annual report of the working of the society during the year.
11. The general body will meet atleast once in a year.
12. Not less than 7 days notice shall be given to the members before the date of general body meeting enclosing the agenda specifying date, time and place.
13. The general body in its annual meeting will elect its President and all office bearers and members after five years by secret ballot and the quorum of the general body and managing committee shall be two third.
14. The strength of the managing committee shall be not less than seven members and not more than eleven members including office bearers.
15. The terms of the managing committee shall be five years.
16. The managing committee will arrange finance if required from other Banks, Institutions or individuals on reasonable terms and conditions.
17. The managing committee shall be responsible for implementation of the decision taken by the general body and will make plan for the future programmes of the society.

18. The managing committee will meet atleast once in a month for which ten days notice will be required.

19. The managing committee will appoint, nominate and six duties of any staff;

20. The managing committee shall comprise of the following:

The managing committee shall comprise of minimum 7 and maximum 11 members.

21. The President will be the head of the society and preside over the meeting of general body and managing committee. He will have the right of lasting vote in case of tie.



22. In the absence of President the Vice President shall set in his place.


23. All the correspondence of the society shall be made under the signatures of secretary or president. He will perform all the duties assigned by the managing committee from time to time.


24. In the absence of Secretary the Jt. Secretary shall act in his place.


25. The cashier will keep accounts of all receipts and expenditures of the society and will furnish necessary informations to the managing committee. He will keep Rs. 200/- with him and the balance amount will have to re-deposited in the Bank.


26. a) Once in a year names of office bearers will be sent to the registrar of Societies.
b) The financial year of the society shall start from 1st. of Jan. to Dec.31, every year.
c) The A/c will be audited annually by an auditor.
27. The society may sue or be sued in the name of President as per section 6 of the societies Registration Act. 1860.
28. Any kind of amendment in the memorandum shall be made as per section 12 & 12A of societies Registration Act 1860.
29. The society may be dissolved as per section 13 & 14 of societies Registration Act 1860.
30. All the provisions of societies Registration Act 1860 (Punjab Amendment Act 1957) as extended to the Union Territory of Delhi shall apply to the Society.

1. Name of the society: Columbia Foundation Society.
2. The Registered office of the society shall situate in the Union Territory of Delhi, at present it is at C-11, Vikas Puri, New Delhi-110018.
3. Aims and objectives: The aims and objects for which the society established are:
 - a) To establish educational institutions for the diffusion of useful knowledge and social welfare of the public;
 - b) To serve the children of poor and middle class families in imparting education to them;
 - c) To provide basic education to all classes of citizens of India without any discrimination to caste or creed;
 - d) To enthuse children as well as the citizens of India towards secularism and socialism;
 - e) To enlighten and create awareness among children as well as citizens with the sense of duty for the Indian society and the Nations;
 - f) To sponsor programmes for children and social welfare;
 - g) To do all such other things which may be conducive to the effectual performance of the aforesaid aims and objects.



NOTE: All income of the society shall be used for furtherance of its aims and objects.
